## **General Information:**

Memberships are accepted from persons 18 years and older and his/her legal spouse/domestic partner. Dependents of the member who are entitled to all the benefits of the membership include a member's unmarried children who have not reached age 21, or who have reached age 21 and are students and financially dependent upon the member. Other persons who are financially dependent upon the member and who currently reside in the member's household may also be considered as dependents pending approval by the board.

An initial initiation fee of \$200 is required for all new members. Currently, annual dues are **\$525**, subject to annual increases, and are invoiced on March 1st and are due by April 15th of each year or within 7 days of the Club's acceptance of membership after May 1st. Annual dues are in addition to the non refundable membership fee. All fees and dues are subject to change by the Board of Directors.

## **Instructions:** Complete all applicable sections of this form and either:

1. Return this application and a check for the non-refundable application fee of **\$25** to the address above. If your membership is accepted, the application fee will be applied to the cost of membership. You will be invoiced for the remaining balance upon membership acceptance. The application fee is forfeited if membership is later declined by the applicant.
2. Return this application and a check for the full amount of **\$725** (\$200 initiation fee and \$525 2024 dues) to the address above.
